

MEMORANDUM OF UNDERSTANDING (MOU)

This MOU made this the 15th day of July 2019 between THE K N S B L ARTS & COMMERCE COLLEGE, KHERALU having its office at Prof. Keshubhai Desai Vidhyasankul, Sidhpur Cross Road, Kheralu, Dist: Mahesana (hereinafter referred to as 'KHERALU COLLEGE') through its authorized signatory and ALKA MULTISPECIALITY HOSPITAL, KHERALU a private hospital having its office at Near Khari Kui, Kheralu, Dist- Mahesana (hereinafter referred to as 'ALKA HOSPITAL').

WHEREAS KHERALU COLLEGE is an educational body engaged in education and interested to avail medical treatment facility for its Female Students.

And this MOU witness and it is agreed by and between the parties as follows:

- 1) A written request for hospitalization (i. e.OPD/ IPD) should be made by KHERALU COLLEGE. This request will be either faxed / e- mailed or hand delivered by the beneficiary and produced at the time of admission along with photo identity proof issued from KHERALU COLLEGE. ALKA HOSPITAL will not provide credit facility without this letter. In emergency, the patient should be treated as per the hospital norms. However the request letter will be submitted latest by next working day.
- 2) ALKA HOSPITAL shall provide concessional rate facility to the female students (as defined under KHERALU COLLEGE rules) for OPD/IPD.
- 3) ALKA HOSPITAL will not provide cashless facility for Medicine, CT Scan, Nuclear Medicine and M.R.I.
- 4) KHERALU COLLEGE will not be responsible for making payments for items such as special attendant charges, telephone, snacks, food and beverages etc. and must be directly collected from the beneficiary.
- 5) ALKA HOSPITAL shall furnish to KHERALU COLLEGE the Details Schedule of charges for various services and will keep informed about any revision in the charges, which may take place from time to time.
- 6) The KHERALU COLLEGE beneficiary will be provided best possible treatment by the panel of consultants attached to ALKA HOSPITAL according to the practice parameters and clinical protocols established by ALKA HOSPITAL.
- 7) MOU can be terminated by either party by giving one month's prior notice.
- 8) Any disputes, claims arising out of this Agreement are subject to arbitration and subject to the jurisdiction of KHERALU courts only.



- 9) Any clauses in the MOU can be affected as an addendum, after the written approval from both the parties.

The MOU shall come into force with effect from 15th day JULY 2019 and will remain in force until terminated by either party by giving written notice to this effect.
