Pratham InfoTech Foundation, Mumbai the Second Party, and represented herein by its Institutional Partnership & Training Associate and representative Mr.Siddharth Dave, (hereinafter referred to as "PIF, Mumbai", organisation which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

(Kheralu College and Pratham InfoTech Foundation are hereinafter jointly referred to as "Parties")

#### Whereas:

- Both parties, Kheralu College and Pratham InfoTech Foundation believe that collaboration and cooperation between themselves will promote more effective use of each of their resources and provide each of them with enhances opportunities.
- The Parties intend to cooperate and focus their efforts on cooperation within area of Empowerment Programs through IBM Skills Build workshops and awareness campaign.

Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest:

NOW THEREFORE IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

## Clause 1: Cooperation

- Both parties are united by common interests and objectives to empower youth/students, and they shall establish channels of communication and cooperation that will promote and advance their respective operations within the Institutions and its related wings.
- Kheralu College and Pratham InfoTech Foundation cooperation will facilitate
  effective utilization of the subject matter expert and intellectual capability of
  students at Kheralu College, providing significant inputs in developing suitable
  ecosystem, keeping in mind the needs of the industry.





# Clause2: Scope of MOU (Statement of work)

- Guest Lectures/Visiting Faculty: Pratham InfoTech Foundation to extend the necessary support to deliver guest lectures to the students of The KNSBL Arts & Commerce College Kheralu on the technology trends, emerging technologies, IT sales skills, IT recruitment and training, methodologies and in-house requirements.
- Pratham InfoTech Foundation will help with course completion to the students and placement support to students of The KNSBL Arts & Commerce College Kheralu party, as and when required in tune with the industry-Academic Relations.
- 3. The KNSBL Arts & Commerce College Kheralu will assign a teacher/ professor in the classroom during session for crowd management.
- 4. Both parties to obtain all internal approvals, contents, permissions and licenses of whatsoever nature required for offering the Programs on the terms specified herein.
- 5. It would be noncommercial agreement between The KNSBL Arts & Commerce College Kheralu and Pratham InfoTech Foundation

# Clause 3: Intellectual Property

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise create in either Party any right, title, interest, or license, in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

Both parties will respect each other's Privacy and IPR policies without any violation. In case of any violation of IPR, the MOU would be terminated immediately.

# Clause 4: Relationship Between the Parties

It is expressly agreed that **The KNSBL Arts & Commerce College Kheralu** and **Pratham InfoTech Foundation** are acting under this MOU as independent organisations, and the relationship established under this MOU shall not be construed as a partnership but shall be considered on the Joint Collaboration for Upskilling of student and placement support.

Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
